CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period up to **MARCH 2024**, or till the project is over on a temporary contractual basis in the project entitled “**Phenome India- CSIR Health Cohort Knowledgebase**”(HCP-0047) tenable at the Department of Microbiology & Fermentation Technology CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: B.Sc./3Years Diploma in Medical Laboratory Technology/ Bio-Medical Technology/ Nursing.

Emoluments: Rs.20,000/- (Twenty Thousand Only) plus HRA per month.
