- 1. Candidates should not have exceeded **28 years** of age as on <u>**04.07.2018**</u>, i.e. the date of walk-in-interview for the position. Age relaxation as applicable by Govt. of India rules for SC/ST/OBC and women candidates will be considered.
- 2. The engagement of PA-II is exclusively for the above mentioned research work.
- 3. The engagement will be contractual and on purely temporary basis in the externally funded project **(SSP-0245)** for a maximum period of **Ten months** and is co-terminus with the project, if the project terminates earlier or till the funds are available, whichever is earlier.
