CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **JUNIOR RESEARCH FELLOW** initially for a period of **03 MONTHS** or till the project is over on a temporary contractual basis in the project entitled "Evaluating the role of Galactomano- Oligosacchrides as potential therapy for inflammatory bowel disease using omics based approaches" (GAP-0597) tenable at the Department of Microbiology & Fermentation Technology, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Life Sciences.

Job Requirements: CSIR-UGC NET or GATE Qualified

Emoluments: Rs.31,000/- (Rupees Thirty One Thousand only) Plus 18% HRA per month.

- 1. Candidates should not have exceeded **28** years of age as on **06-11-2022** i.e. the last date of receiving the applications.
- 2. The engagement of **JUNIOR RESEARCH FELLOW** is exclusively for the above-mentioned research work.
- 3. The engagement will be contractual and purely on temporary basis for a period of 03 Months or co-terminus with the project, whichever is earlier.
- 4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
- 5. Performance of the Project Staff will be reviewed periodically. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
- 6. No TA/DA will be given to the candidates for attending the interview.
- 7. If already the candidate is working in CSIR-CFTRI "No objection certificate" from the PI is mandatory at the time of interview.
