CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02** (**Two**) positions of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **06 MONTHS** or till the project is over on a temporary contractual basis in the project entitled "Evaluation of **RIL algal biomass as a dietary protein source on growth performance, immunological parameters, and meat quality of broiler chicken "(SSP-0348) tenable at the Department of Meat & Marine Science, CSIR-CFTRI, Mysuru, Karnataka.**
