CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02** (**TWO**) positions of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **06 MONTHS**, extendable based on performance or till the project is over on a temporary contractual basis in the project entitled **"Development of functional oleogel based bakery products" (MLP- 0304)** tenable at the Department of **Flour Milling, Baking & Confectionery Technology** CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: B.E. / B. Tech in Food Process Engineering / Food Technology / Food Science & Technology or M.Sc. Nano Science & Technology (Minimum 55% Marks).

Job Requirements: To carry out the R&D work as assigned. Mainly in the area of Materials characterization / Analytical techniques aspects [Microscopy, Spectroscopy, X-ray diffraction, Thermal analysis, Rheometry & Chromatography]

Emoluments:

- (i) Rs.31,000/- per month plus 16% HRA to Scholars who are selected through (a) National Eligibility Tests CSIR-UGC NET including lectureship (Assistant Professorship) or, GATE or (b) A selection process through National level examinations conducted by Central Government Departments and their Agencies and Institutions
- (ii) Rs.25,000/- per month plus16% HRA for others who do not fall under (i) above.

Terms and Conditions:

- 1. Candidates should not have **35** years of age as on **09-10-2022** i.e. the last date of receiving the applications.
- 2. The engagement of **PROJECT ASSOCIATE LEVEL-I** is exclusively for the above-mentioned research work.
- 3. The engagement will be contractual and purely on temporary basis for a period of six months, extendable based on performance or co-terminus with the project, whichever is earlier.
- 4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
- 5. Performance of the Project Staff will be reviewed Periodically. In case the performance is not satisfactory, the engagement could be terminated with one month's notice or one month's stipend in lieu thereof.
- 6. No TA/DA will be given to the candidates for attending the interview.
