# Engagement to the position of Project Associate – II (PAT-II) & Project Assistant-II (PA-II)

CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), desires to engage qualified candidates as **Project Associate- PAT II & Project Assistant-II (PA-II) purely on temporary contractual basis** on the below-mentioned projects:

"CSIR JIGYASA 2.0 Programme with concept of Virtual Laboratory Integrated" (HCP-0101): A CSIR-Student Science Outreach Initiative. It is expected that high school students from KVS, JNV and Government High Schools be familiarized with R&D at the institute and motivate them towards achieving rational thinking and scientific temper.

For the project entitled "CSIR JIGYASA 2.0 Programme with concept of Virtual Laboratory Integrated" (HCP-0101) the engagement is initially for a period up to March 31, 2026 funded by CSIR tenable at the Department of Biochemistry, CSIR- CFTRI, Mysuru, Karnataka. The details are as follows:

**Desirable Qualification/Experience:** Experience in handling High School Students for Scientific Events and fluent in Kannada.

**Note:** As per CSIR OM No. 5-1(342)/2017-PD dated 02.09.2024, engagement of Project Staff shall be co-terminus with the term of the Project subject to the condition that the total period of the engagement of a Project Staff in different projects either in the same Lab/Instt. or different Lab/Instt. of CSIR taken together shall not exceed 6 years in any case. Hence, the applicants who have completed the total tenure of 6 years in any of the CSIR Lab/Instt. as Project Staff are NOT ELIGIBLE to apply for the aforesaid positions.

## **Terms and Conditions:**

- a) Candidates should not have exceeded 35 years of age as on **09.06.2025** i.e. the last date of receiving the applications.
- b) Only those candidates who have already acquired the essential qualification & their results have been declared are eligible to apply. Result awaited /Final semester appeared or appearing are not eligible to apply for any post.
- c) The period of experience in a discipline / area of work, wherever prescribed, shall be counted after the date of acquiring the minimum prescribed educational qualifications prescribed for that post.
- d) The applicants will be subjected to shortlisting by designated committee according to the current requirement and the candidate's shortlisted for interview will be displayed on CSIR- CFTRI website. No TA/DA will be given to the candidates for attending the interview.
- e) In the event of large number of applications, the duly constituted committee will adopt its own criteria for short-listing the candidates to restrict the number of candidates to be called for interview to a reasonable number by any one or more of the following methods:
  - i) On the basis of percentage of marks obtained in the Essential Qualification.
  - ii) On the basis of higher educational qualifications than the minimum prescribed in the advertisement.
  - iii) On the basis of desirable Qualification/ experience.
  - iv) Any other methodology as deemed fit by the Committee
- f) Based upon the performance of candidates in the interview, result of selected candidates against the number of post available in the project for each post code, will be declared and posted on CFTRI website. Selection for engagement, panel of waitlisted candidates and its validity will be as per CSIR rules vide OM No. 5-1(342)/2017-PD dated 02.09.2024 amended from time to time.
- g) Relaxation in age limit for the candidates belonging to the category of SC/ST/PwBD/Women and the category of OBC shall be 05 years and 03 years respectively.

- h) The Engagement under any of the above position(s) shall be on behalf of the sponsoring agency and shall be temporary and co-terminus with the tenure of the Project or 06 years whichever is earlier. Further, such engagement, directly or indirectly, shall not provide any right/claim for regularization for a permanent post of CSIR-CFTRI/CSIR, against any post or otherwise under any legal conditions or precedent. If already the candidate is working in CSIR/CSIR-CFTRI a "NOC" from the current PI is mandatory for applying for the aforementioned project. In a case, if selected, Engagement under this project would be made only after submission of 'No Dues Certificate' and resignation from the previous project.
- i) The engagement shall be initially for a short duration based on availability of funds which may be extended or curtailed based on the conduct and the performance of the incumbent as well as requirement of the institute which may be extended further based on the recommendations of the Review Committee. However, the engagement will not be beyond the tenure of the project and shall expire automatically on the expiry of project tenure, in which candidate has been selected.
- j) Please note that mere engagement as project personnel shall not confer any such personnel the right to register for higher degrees or permanent employment in CSIR-CFTRI or CSIR or its Laboratories/Institutes.
- k) The maximum duration, for which Project staff could be engaged in different projects taken together, will be 6 years. Candidates who have already served CSIR-CFTRI or any other lab/ institute of CSIR as Project Staff at any level in CSIR projects (including NMITLI projects, OLP/MLP, Contract R&D and non-CSIR funded projects) for a total period of 6 years or more are not eligible for these engagements.
- The posts advertised are provisional and subject to ascertaining the availability of funds under the respective project before the declaration of results and issue of engagement letter.
- m) The performance of the Project Staff would be reviewed periodically so that any one not found up to the mark, could be terminated. The engagement may be terminated at any time by the office without assigning any reasons.
- n) CSIR-CFTRI reserves the right to cancel or withdraw the offer of engagement in case of any discrepancy found, in the candidature of any empanelled candidate at any stage.
- o) Candidates who are applying for any of the above post shall ensure that they fulfil the essential qualifications/experience. If they apply without fulfilling the essential qualifications, then it will be considered that they are giving wrong/misleading information. The ONUS OF THIS ACTION WILL BE ON THE CANDIDATE and not on the Institute. In case they are found not fulfilling the essential criteria or that they have provided misleading information, then their candidature for the post may be rejected at any stage of selection or after selection.
- p) Other terms and conditions will be governed as per guidelines issued by CSIR/funding agency for the engagement of above project staff as amended from time to time.
- q) The Director, CSIR-CFTRI has a right to amend, delete and add Terms & Conditions to this notification and also reserves the right to cancel the advertisement without assigning any reason thereof or reserves the right not to fill up the posts, if required. The number of vacancies indicated above may vary i.e. it may increase or decrease at the time of actual selection.
- r) CANVASSING IN ANY FORM AND/OR BRINGING ANY INFLUENCE POLITICAL OR OTHERWISE WILL BE TREATED AS A DISQUALIFICATION FOR THE POST.

The onus of selecting subject panel will be on the candidate only.

Applications of those candidates, which are already active in the above panels listed against each position with the above eligibility requirements will be considered by default. Applications received after the due date **09.06.2025** will not be considered.
