CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **01 Year extendable up to FY 2024-2025 (preferably up to August 2024)** or till the project is over on a temporary contractual basis in the project **“Development of functional oleogel based bakery products” (MLP-0304)** tenable at the Department of Flour Milling, Baking & Confectionery Technology, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:** B.Sc. in Food Science / Nutrition / Technology/ Chemistry.

**Job Requirements:** Preferably M.Sc. (Food Science / Nutrition / Technology/ Chemistry) with R&D experience (Wheat Based Bakery & Extruded Products Processing).

**Emoluments:** Rs.20,000/- (Rupees Twenty Thousand only) plus HRA per month .
