CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled **“Global migration studies on Plastics & Laminates” (OLP-099)** at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc. (Chemistry / Poly Science) or B.E (Polymer Science).

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) consolidated per month.

1. Candidates should not have exceeded **35** years of age as on **15-04-2022** i.e. the last date of receiving the applications.
