CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **18 Months** or till the project is over on a temporary contractual basis in the project entitled “**NMR (Nuclear Magnetic Resonance) based metabolites profiling of coconut water (GAP-0619)**” tenable at the Department of Spice and Flavour Science, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Chemistry (Any discipline).

Job Requirements: To carry out R& D activities related to define project.

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) consolidated per month.

Terms and Conditions:

1. Candidates should not have exceeded **35** years of age as on **20-07-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL - I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of 18 months, and co-terminus with the project, whichever is earlier.

5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the engagement could be terminated with one month's notice or one month's stipend in lieu thereof.

7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
