CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **07 MONTHS** or till the project is over on a temporary contractual basis in the project entitled "**Moisture Sorption Isotherm studies & Prediction of Shelf life of Nutrition Food Products**" (**SSP-337**) tenable at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.
