CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year**, or till the project is over on a temporary contractual basis in the project entitled “**Value-added dietary formulation by the virtue of Coconut milk Exosomes and Sesamol: A novel Co-adjuvant therapeutic approach targeting breast cancer**” (GAP-0627) tenable at the Department of Biochemistry, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: 1st Class in M.Sc. Biochemistry / Biotechnology/ Lifesciences.

Job Requirements: Cell Culture handling, Biochemical and Molecular biology techniques.
