It may be noted that mere selection of the candidate does not entitle him/her for appointment to the above posts, as the selection is purely provisional and subject to fulfilment of eligibility in all respects and medical examination to be undertaken by appropriate authority before the appointment.

The selected candidates mentioned above are being intimated separately for completion of pre-appointment formalities like submission of attestation forms, certificate of fitness from Medical Board, Character & Antecedents certificate, etc. before issuance of offer of appointment.

In case of candidates who have stayed / have been staying abroad for more than a year during the preceding five years, their offer of appointment will be issued subject to receipt of clearance from Intelligence Bureau.

It may be noted that the selection to the reserved posts (i.e. SC/ST/OBC(NCL)/EWS) will be provisional and subject to the verification of caste/community/category/ Income and Asset certificates through proper channels. If the verification reveals that the claim of the candidate that he/she belongs to SC/ST/OBC(NCL)/EWS is false OR in case of OBC(NCL) candidates, if it reveals that the claim of the candidate that he/she belongs to non-creamy layer is false, his/her services will be terminated forthwith without assigning any further reasons.
