The Open Competitive Written Examination for recruitment to the posts of Technical Assistant against Advt. No. Rec.03/2025 was held on 21-12-2025. The Question papers & Provisional Answer keys for Paper - I, Paper- II & Paper-III (Concerned Subject) are enclosed herewith.

**The candidates who have appeared in the above-mentioned Written Examination can raise challenge(s), if any, against the Provisional Answer Keys during the period from 22.12.2025 (10:00 AM) to 24.12.2025 (17:30 hrs) on payment of a non-refundable processing fee of Rs. 100/- per question challenged through SBI Collect till 24.12.2025 (17:30 hrs). No challenge will be entertained without receipt of the processing fee. The fee towards the challenge will not be accepted through any other mode. Candidates may also note that this fee is strictly non-refundable, including in instances where the challenge is found to be valid.**

**Candidates are required to log in on the CFTRI Recruitment portal (i.e., <https://recruitment.cftri.res.in>) using Roll Number & Date of Birth and click on “Submit Challenges against Provisional Answer Key(s)” to raise challenges. Candidates can raise the Representation for the Provisional Answer Key(s)” clearly mentioning the Question Paper (I or II or III) as the case may be, duly enclosing documentary evidence in support of his/her challenge. The representation(s) received after 24.12.2025 (after 17:30 hrs) will not be considered under any circumstances.**

Representations/ Challenges for the Provisional Answer Keys received through any other mode i.e. letter, email, phone, application etc. will not be entertained. In case of any difficulty in raising the objections through the portal against the Provisional Answer keys, the candidate may contact on email: [recruitment@cftri.res.in](mailto:recruitment@cftri.res.in). This email is only for Technical Queries related to accessing the portal.

Challenges made by the candidates on the portal will be verified by the Question Paper setter, and if found correct, the answer key will be revised accordingly. The decision of the competent Authority of CSIR-CFTRI in this regard will be final and binding on the candidates. Based on the verified Final Answer Key, the result will be prepared. No grievance with regard to answer key(s) after declaration of result will be entertained.
