India is the world's largest producer, consumer and exporter of spices; the country produces about 75 of the 109 varieties listed by the International Organization for Standardization (ISO) and accounts for half of the global trading in spices. Indian spices are the most sought-after globally, given their exquisite aroma, texture, taste and medicinal value. India has the largest domestic market for spices in the world. Spice production in India during 2020-21 stood at 10.7 million tonnes growing at an 8% Compound annual growth rate since 2014-15. For the year 2020-21, the country continued its upward trend and exported spices worth US\$ 4.18 billion, a 34% increase from the year 2019-20. CSIR-CFTRI is organizing one day exclusive workshop focusing on the spice processing under CSIR Integrated Skill Initiative. The daylong session would be an ideal opportunity for budding entrepreneurs / microentrepreneurs / startups / SHGs / and entrepreneurial aspirants. The applicant has to upload proof of valid Identity Card (Driving License / Aadhaar Card / Voter ID / PAN Card / Passport / Bank Passbook with photo), passport size photograph recently taken and e-receipt of payment made against registration fee. (application will be rejected in absence of these documents).
- 9. Educational Qualification: XIIth / PUC / Diploma or higher qualifications
- 10. Online Sessions: The program will be conducted through online on Microsoft Teams. It is recommended to use a Laptop/Desktop computer installed with Microsoft Teams and a reliable internet connection to attend the sessions.
- 11. After the scrutiny of the applications for necessary documents & payment confirmation, applicants will get the meeting link, detailed schedule and instructions on 19th September 2022.
- 12. Attendance: The registered applicants have to attend this workshop. At least 80% attendance is required for successful completion.
- 13. e-Certificates will be issued to those who successfully completes the program.
