Sub: Notification of Result for recruitment to the posts of Technical Assistant notified vide CFTRI
 Advt. No. Rec.36/2018 - Reg.

As per CSIR-CFTRI Web Notification dated 13-01-2025, the Competitive Written Examination for the Recruitment of Technical Assistants against CSIR-CFTRI Advertisement No. Rec.36/2018 was conducted on 09-02-2025 for all the post codes. There were three Papers (Paper- I, II & III) in which Paper-I & Paper-II is common for all posts and Paper-III is particular to the subject/area of Essential Qualification for the corresponding post code.

As per the advertisement and Selection Scheme for these posts, the final merit list will be prepared only on the basis of the combined marks obtained by the Candidates in Paper-II and Paper-III. Paper-II & III will be evaluated only for those candidates who secure the minimum threshold marks in Paper-I, as decided by the Selection Committee.

Accordingly, the Selection Committee fixed the following threshold marks for Paper-I to all the post codes:

The candidature of the selected candidates for the aforementioned posts is provisional and is subject to the verification of all original documents such as Educational Qualifications, Experience, caste/category etc. Further, if it is found, at any point of time, during the recruitment process, even after the appointment, that the candidate doesn't fulfil the minimum eligibility criteria or other terms and conditions of the posts advertised vide CSIR-CFTRI Advt. No. Rec. 36/2018 and/or subsequent CFTRI web notifications released in connection with the recruitment to these posts, his/her candidature will be cancelled/rejected without any further notice, and no appeal against such cancellation will be entertained. Candidates are, therefore, advised to check carefully and satisfy themselves, that they fulfil all conditions of eligibility for the post they have been selected.

It may be noted that the selection to the reserved posts (i.e SC/ST/OBC) will be provisional and subject to the verification of caste/category/community certificate through proper channels. If the verification reveals that the claim of the candidate that he/she belongs to SC/ST/OBC is false, his/her services will be terminated forthwith without assigning any further reasons.

While every care has been taken in preparing the above result, however, CSIR-CFTRI reserves the right to rectify inadvertent error or typographical/printing mistake, if any.

The provisional offer of appointment will be issued to the candidates, subject to the verification of original documents and completion of pre-appointment formalities before joining the post. The document verification will be conducted on 02-04-2025 at CSIR-CFTRI, Mysuru and intimation regarding the same will be communicated to the selected candidates individually through email.

The details of marks obtained by the candidates in the competitive written exam will be published on CFTRI website after the document verification. No individual candidate will be informed about the marks separately through any other mode.
