Steam boiler with accessories

Non-IBR steam boiler with accessories for generation and supply of steam at 100 °C. Complete with all auxiliaries, accessories, control and safety measures for the smooth operation.

Capacity : 300 kg/h
Quantity : 02 Nos.

Steam pressure : 10.50 kg/cm²
Fuel to be used : HSD/ LDO

Thermal efficiency : 88±2% (Minimum)

The boilers to be installed at the different places. The boilers to be operated independently and supply of fuel, steam, water to be provided from separate tanks. The steam supply line from each boiler to be given to separately with steam distribution header.

The scope of supply includes:

- Boiler with double helical vertical coil with all standard auxiliaries like firing burner assembly, blower with motor, fuel pump, water pump, control valves, economizer, control panel, strainer/moisture separator assembly, tool kit etc.
- Piping for feed water, fuel oil, mountings & fittings, steam control valves, safety valves.
- Water & fuel strainer, control valves, fuel filters.
- Instruments control & safety measures like burner programmer with matching flame detector, audiovisual alarms for abnormal conditions.
- Pressure gauge, temperature indicator cum controller, ON-OFF control for burner, water level alarm, fuel pressure indicator etc.
- Fuel gas and combustion air system: Fabrication & erection of duct with suitable reducer, bend and flange joints, thermometer with sampling point.
- Chimney: Erection & Commissioning & Fabrication of wall mounted chimney as per Karnataka State Pollution Control (material, height, diameter and thickness) should be

- connected to each boiler. MS ladder provision to check the pollution reading above a distance of one meter from the last bend of the chimney.
- **Feed water system:** Resin type water softeners (namely: Omega/Thermax/Serene Aqua Tech) for supplying soft water for each boiler, with PVC feed water tank (~1000 L each, with level indicators), flow and drain piping with required valves and fittings.
- **Fuel Supply:** Fuel supply system consist of MS tank (500 L each, with level indicators and inside anticorrosive coating), flow and drain piping with required valves and fittings along with a suitable diesel pump.
- **Drain Lines:** Drain and boiler bypass, Economizer & Air vent drain, blowdown drain.
- **Support and Structure:** for pipe racks & boiler feed tanks. All the structure and uninsulated area to be applied with red oxide primer and final enamel paints.
- MS-Pipe "C" Class- NIBR, Flanges "C" Class (NIBR), Short Bend "C" Class (NIBR) as per actual requirement
- **Insulation:** Insulation with mineral wool/polyurethane/glass wool/fibre glass with chicken mesh & with Aluminium cladding for steam line up to header outlet.
- Others: Fasteners, Barrel Nipples, Gaskets, Teflon Tape etc. for installation, commissioning and successful operation of Boiler.

All motors (Crompton/Kirloskar/Siemens), electrical/electronic controls (Havells/Siemens/MDS), pumps should be of standard make and all parts & components used in the system to meet the standard regulations. For quick repair/trouble shooting and maintenance of boiler, the firm should have service office/facility in Mysore or Bangalore.

Warranty: ONE year from the date installation, commissioning and demonstration of successful operation.

It is mandatory for all the bidders to upload duly filled Price Schedule Format/BOQ towards submission of their Financial Bid. No changes or modification to the given format is acceptable. Bidders are required to go through the <u>instructions</u> carefully before filling the Price Schedule Format/BOQ.

Payment for Goods and Services supplied from India:

Payment for Goods and Services supplied from within India shall be made in Indian Rupees [INR] only as follows:

- **B.** Inland Letter of Credit: The inland L/C will be confirmed at the suppliers cost, if requested specifically by the supplier. All bank charges shall be to the account of the beneficiary i.e. Supplier. P.S:

As per OM No. 6/18/2019-PPD dt 23/07/2020, under Rule 144(xi) in GFR 2017, Requirement of Registration is mandatory for:

Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services (including turnkey projects) only if the bidder is registered with the Competent Authority.

Special Clauses for Tenders

- I. Any bidder from a country which shares a land border with India will be eligible to
 - bid in this tender only if the bidder is registered with the Competent Authority
- II. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain
 - contexts) means any person or firm or company, including any member of consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of
 - bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process
- III. "Bidder from a country which shares a land border with India" for the purpose of this Order means:
 - a) An entity incorporated, established or registered in such a country; or

- b) 'Control" shall include the fight to appoint majority of the directors or to control the management or policy decisions Including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
- 2. In Case of A partnership firm the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more Juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more Juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the: relevant natural person who holds the position of senior managing official,
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership
- V. An Agent is a person employed to do any act for another, or to represent another in dealings with third person
