1. Online Item rate e-tender is invited through the e-tendering portal <https://etenders.gov.in/eprocure/app> in two cover system from the eligible contractors for the work "Construction of Security Watch Tower near FMBCT building at CSIR-CFTRI, Mysuru." The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the **last five years, ending on the last day on the month previous to the one in which tender is being invited.** Similar works as above mentioned refers to **only steel work in steel bridge work, space frames for long span structures, steel towers and Pre-Engineered Building(PEB) structures and pre fabricated steel structures like industrial sheds, warehouses.** The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates, tender acceptance letter, relationship declaration and EMD declaration.
2. The Estimated cost of work is **Rs 6,92,158/- (Rupees Six lakhs ninety two thousand one hundred and fifty eight only)** based on CPWD, DSR-2019 (Including relevant current cost index) and prevailing market rates inclusive of GST. Duration of contract for carrying out of the work will be **90 days (Ninety Days)** including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
3. **Bid Submission:** Bids shall be submitted through online at CPP Portal: <https://etenders.gov.in/eprocure/app> by the tenderer, as per date given in Critical Date Sheet below. The instructions for the submission of e-tender are available on the CPP portal i.e. <https://etenders.gov.in/eprocure/app> under the "**Instruction for Online Bid Submission**". All the intending tenderers are requested to go through these instructions before entering into the process of e-tendering of this work and advised to visit again CPP Portal regularly till closing date of submission of tender for any corrigendum/ addendum/ amendment. **Manual tenders shall not be accepted.**
