1. Online Item rate **Limited e-tender** is hereby invited through the e-tendering portal "<https://etenders.gov.in/eprocure/app>" in two cover system, for the civil work "**Restoration of existing 4.50 lakhs litres capacity RCC overhead tank near football ground in the premises of CSIR-CFTRI, Mysuru**" from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government organizations, reputed private organisations or those who have successfully carried out works for CSIR or its laboratories .The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT **during the last five years, ending on the last day on the month previous to the one in which tender is being invited.** Similar works as above mentioned refers to **restoration works of RCC overhead water tank and other retrofitting works of civil structures.** The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates certificate from the respective clients, tender acceptance letter, relationship declaration and EMD declaration.

The Estimated cost of work is **Rs 20,17,778/- (Rupees Twenty lakhs seventeen thousand Seven Hundred and seventy eight only)** based on CPWD, DSR-2019 (Including relevant current cost index) and prevailing market rates inclusive of GST. Duration of contract for carrying out of the work will be **90 days (Ninety days)** including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
