

- 1. Should be an Indian National and Income Tax Payer having an authenticated PAN.
- 2. Should be an established and reputed Caterer duly registered for providing catering services having Head Office/Branch Office at Mysuru.
- 3. Should have a minimum 5 years of experience obtained during last ten years as on 30/11/2021 for running canteen and providing catering services in Government establishments/Public Sector Undertakings/R&D Institutions/Academic Institutions/Corporate Houses /Other established Organizations. The turnover of the firm should not be less than 60 lakhs per annum.
- 4. Should have requisite manpower including qualified personnel with expertise and skill in catering service.

- 5. Should be financially sound with no records of any default on any nationalized and/or scheduled Banks as well as private financial organizations, both in India and abroad.
- 6. Should submit a Solvency Certificate for an amount not less than Rs.10 lakhs from any Nationalised/Scheduled bank within the last six months as on the date of NIT.
- 7. Should have no record of any statutory dues and disputed liability and claims.
- 8. Should have registration with a) Labour Commissioner of the State/Central Government b) ESI c) EPF and d) GST authorities.
- 9. Above all, should have the working knowledge and experience of in-house hygiene and sanitation during cooking / serving and to maintain high standard of quality attributes of food being served to the guests and students.
- 10. Valid Form-B issued by Food Safety & Standards Authority of India (FSSAI).
- 11. Any other statutory obligations as are required from time to time.
