Online e-tender (limited tender) is hereby invited through the e-tendering portal "<https://etenders.gov.in/eprocure/app>" in two cover system, for work " **Setting up of 35 KLD capacity Sewage Treatment Plant (STP) near IFTTC Hostel Block at CSIR-CFTRI, Mysuru on turnkey basis** " from the registered firms or contractors who has already been shortlisted through the Expression of Interest. The contractors shall apply along with copies of PAN Card, GST registration certificate, valid firm's or contractor's registration certificate of appropriate class, tender acceptance letter, relationship declaration etc. Before execution of work, the contractor shall produce proof of possessing valid **Class 1 Electrical License** of the Contractor or **Class 1 Electrical license of sub-Contractor** engaged for the execution of electrical nature of work by the main firm / contractor.
2. The Estimated cost of work is **Rs. 37,52,286/- (Rupees Thirty-Seven Lakh Fifty-two Thousand Two Hundred and eighty-six only)**. The Earnest Money Deposit (EMD) is **Rs. 75,000/- (Rupees Seventy-five thousand only)**. Duration of contract for carrying out of the work will be **90 days (Ninety days)** including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
