Specifications and Allied Technical Details for Supply, Installation and Commissioning of GENOMICS WORK STATION

4.1 End Use: Research and Development

4.2 Detailed Technical Specifications for GENOMICS WORK STATION

Specifications for Mini horizontal electrophoresis system:

- The System should be capable of fast , economical nucleic acid separation with gel dimensions of 7x7cm .
- The System should include 8- and 15-well combs
- The system should come with QuickSnap electrodes that would be easy to remove and simplify cleaning procedures.
- The system should come with UV-transparent gel trays with fluorescent ruler
- The instrument should come with accessories like casting gates to cast gels right in the cell, and a gel caster for tape-free casting
- The tank should be made with single moulded plastic.

Specifications: PCR Thermal Cycler

- Should have a sample capacity of 2x 96 ,0.2ml tubes, 0.2ml tube strips or 1x96-well plate with Peltier heating and cooling.
- Should have gradient capability
- Should have the feature of dynamic ramping (identical hold times) for all the 8 rows of a gradient
- The instrument should be capable of 2x96 well independent PCR reactions with exact protocol parameters including the rate of ramping and algorithms for gradient generation such that 2x96 well PCR throughput can be achieved with no differences simultaneously.
- Should have a temperature differential range of 1-25degC.
- Should have intuitive 5.7” or More (14.5 cm) touch screen interface which can displays graphics in high resolution for easy programming.
- The touch screen should be responsive for both gloved and ungloved fingers.
- Should be capable of running reaction volumes from 1-100ul. • Should have a maximum ramp rate of 4 degC/second with an average ramp rate of 2.5degC.
- Should have a temperature range of 4-99 deg C
- Should have a gradient range of 30-99 deg C
- Should have a temperature accuracy and uniformity of ± 0.5 deg C
- Should have a memory of >500 programs with further expansion through a USB Flash drive for transfer of files.
- Should have block and calculated temperature control modes.
- The software should have exportable Run logs and system error logs
- Should have quick boot up time of not more than 1 min.
- Should be quiet in operation.
- System should have built in library of standard protocols for long PCR, fast PCR, reverse transcription PCR etc.
- Should have the feature of “instant incubation” to keep samples at constant temp. For ligation and restriction digests.
- Should have power save mode.
- Should be compatible with all kind of plastic consumables and reagents especially reusable sealing Mats.

Specification for Real Time PCR Machine

- System should run real-time PCR experiments without being attached to a computer. When operated as a stand-alone instrument, the instrument will save at least 1000 run files.
- Real-time data traces can be viewed during a run from the thermal cycler screen.
- System should be able to detect a 1.3-fold change in gene expression.
- Thermal gradient for optimization of multiple temperatures in a single assay. Temperature differences of up to 24 °C front-to-back can be created.
- Peltier-driven thermal cycler with maximum ramping speed of 5 °C/sec, with an average ramp rate of 3.3 °C/sec.
- Should have a thermal block operational range of 4–99 °C.
- Sample block temperature accuracy is +/-0.2 °C of programmed target at 90 °C, with a uniformity of +/-0.3 °C well-to-well within 10 seconds of arrival at 90 °C.
- Optical system should allow excitation and detection of up to five fluorescent dyes in a single reaction well. The camera should be factory calibrated for following fluorophores: FAM/SYBR Green, VIC/HEX/Yellow/JOE/TET, CAL Fluor Gold 540, Cal Fluor Orange 560, ROX, Texas Red, CAL Fluor Red 610, TEX 615, Cy5, Quasar 670, Quasar 705, Cy5.5.
- All the mentioned dyes should be factory calibrated without any requirement for frequent calibrations. If regular dye calibration is required, **cost of calibration for 10 years minimum including the consumables should be included in the cost.**
- New dyes can be calibrated in the machine without any additional hardware or filter changes.
- The system does not require internal reference dyes such as ROX for data normalization.
- Optics independently should illuminate and detect fluorescence from each well with the same LED/detector pair per channel. The system should have six filtered LEDs for illumination and differentially detects emission using six filtered photodiodes (one for each channel plus FRET).
- System must have fixed optical path, directly over each well, eliminates the need to normalize for positional bias.
- Absorption spectra in the 500–600 nm; Emission spectra in the 515–730 nm range.
- The system should come with dynamic range of 10 orders of magnitude.
- It should detect one copy of target sequence in human genomic DNA.
- Users should be able to run reaction volumes from 2–50 µl.
- Instrument should detect ≤10 fmol of fluorescein.
- System should continue to run and complete a run if the software is stopped or interrupted to prevent run data from being lost in case if there is unintentional interruption of the software. This function is especially valuable for precious or limited samples, whereby all data is not lost for a run that was interrupted.
- System should directly connect to a network file storage location through Wi-Fi or ethernet with user credentials and can read and write, given system access rights.
- System should connect to cloud platform for remote monitoring, experiment set up, and data analysis.
- A single software platform should take care of operations and data analysis.
- The software should be license free allowing unrestricted installations and should be MIQE compliant.
- Software should be capable of data collection, perform various experiments like gene expression, allelic discrimination, nucleic acid quantification and data analysis like t-Test, one-way ANOVA and be able to generate publication ready bar charts, volcano plots, box & whisker plot & annotate with p values.
- Software should allow users to combine data from different runs into single analysis.
- Software should have features to enable selection of suitable reference genes through gene stability study.
- Data graphs and tables should be exported into Microsoft Excel or printed from software directly.
- User should be able to generate reports by exporting run information, data tables, graphs, and analysis parameters in a specified order to PDF or other file formats.

- Software should enable integration with any laboratory information management system (LIMS) using built-in LIMS file management as well as simultaneously run upto 4 instruments from the same computer.
- The software should have the option to be upgraded to 21CFR part 11 compliant version.
- Vendor should have more than **15 installations of the rt-pcr instruments in the country. User list and reference letters must be attached.**
- The specifications should be authenticated by brochures and company website/catalogue. Technical catalogue or brochure of the model must be provided.
- If the need be, the qualifying bidders may be required to place the demo model of the quoted equipment in the Department for testing the efficiency of the equipment. Based on the efficiency and the results obtained the technical committee may further disqualify the vendors and shortlist the vendors whose financial bid will then be opened.

Specifications for Power Supply:

- The Power Supply Unit should offer the following or better output specifications:
 - **Voltage:** Adjustable from 10 to 300 Volts, in 1 volt increments.
 - **Voltage Accuracy:** $\pm 2\%$ of reading or 3 volts, whichever is more
 - **Current:** Adjustable from 4 to 400 milli amperes (mA) in 1 mA increments.
 - **Current Accuracy:** $\pm 2\%$ of reading or 3 mA, whichever is more.
 - **Power:** 75 watts (maximum).
 - **Four output jacks:** Up to four identical electrophoresis cells can be connected in parallel to the power supply.
- The Power Supply Unit should carry the following or better features:
 - Programmable constant voltage or constant current with automatic crossover
 - Timer control from 0 to 999 minutes
 - Display Functions: 3-digit LED displays voltage, current, or time
 - Pause mode for editing running parameters
 - Automatic detection of no load conditions and rapid changes in resistance
 - Power Failure Detection in timed modes allowing completion of run

On the event of the ordered item failing to pass the acceptance test, a period not exceeding two weeks will be given to rectify the defects and clear the acceptance test, failing which, the Purchaser reserve the right to get the equipment replaced by the Supplier at no extra cost to the Purchaser.

Successful conduct and conclusion of the acceptance test for the installed goods and equipment shall also be the responsibility and at the cost of the Supplier.

6.1 Eligibility Criteria

a) Legal Valid Entity:

The Bidder shall necessarily be a legally valid entity either in the form of a Limited Company or a Private Limited Company registered under the Indian Companies Act, 1956 or as per rules prevailing in the country of origin/shipment

Bidder may be Joint Venture, Consortium or Association so long as they are formed and registered prior to the bid submission date.

Copy of Certificate of Incorporation issued by Registrar of firms/companies is to be submitted in support of this criterion or as per rules prevailing in the country of origin/shipment

b) In case of Global Tender Enquiry, Indian Agent quoting on behalf of Foreign Principal Supplier should submit a certified copy of an Agreement/Memorandum of understanding (MOU) between both the parties, detailing services to be rendered by the Agency.

c) An undertaking (self-certificate) is to be submitted to demonstrate that the bidder satisfies the bidders' eligibility criteria, as mentioned in ITB Clause 1.1.2 in the form of declaration by the Bidder for Code of Integrity & conflict of interest as per **Chapter-8: Annexure-L**.

d) Declaration by the bidder on letter head that he has not been disqualified or black listed or suspended by any other lab of CSIR or any other Govt. Organization/Govt. of India establishment or suspended by CPPP or GEM portals, in the past 24 months.

6.2 Technical Qualification Criteria

Criteria 1 - Experience and Past Performance:

6.3 Financial Qualification Criteria -NA

- a) The average annual financial turnover of 'The bidder' during the last three years, ending on 'The relevant Date', should be at ₹.....NA..... as per the annual report (audited balance sheet and profit & loss account) of the relevant period.
- b) A copy of the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries, is to be submitted in support of this criterion. NA
- c) The net worth of the Bidder firm (manufacturer or principal of authorized representative) should not be negative on 'The Relevant Date' and also ii) should have not eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date' (31-03-2023). Self-declaration on letterhead of the company to be provided in support of this. (Documentary evidence or supporting document).

Note: In case of Indian Bidders/companies (manufacturer or principal of authorized representative) who have been restructured by Banks in India, under the statutory guidelines, they would be deemed to have qualified the Financial standing criteria considering the institutional financial backing available to them.

Applicability in Special Cases:

- a) **Applicability to 'Make in India':**
Bidders (manufacturer or principal of authorised representative) who have a valid/approved ongoing 'Make in India' agreement/ program and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided:

i)	their foreign 'Make-in-India' associates meet all the criteria above without exemption, and
ii)	the Bidder submits appropriate documentary proof for a valid/approved ongoing 'Make in India' agreement/program.
iii)	the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enforceable undertaking jointly executed by themselves and such foreign Manufacturer for satisfactory manufacturing, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

- b) **Authorized Representatives:**
Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided:

i)	their principal manufacturer meets all the criteria above without exemption, and
ii)	the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
iii)	the bidder him self should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.

c) **Joint Ventures and Holding Companies:**

Credentials of the partners of Joint ventures cannot be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

Note for Bidders:

a) 'Doctrine of Substantial Compliance':
The Pre-Qualification Bidding (PQB) and Pre- Qualification Criteria (PQC) are for shortlisting of sources who are competent to perform this contract to ensure best value for money from expenditure of Public Money. This process is neither intended to bestow any entitlement upon nor to create any rights or privileges for the Bidders, by way of overly hair-splitting or viciously legalistic interpretations of these criteria, disregarding the very rationale of the PQB and PQC. Keeping this caveat in view, interpretation by the Purchaser would be based on common usage of terminologies and phrases in public procurement in accordance with the 'Doctrine of Substantial Compliance' and would be final.

b) The Bidder must declare, whether asked or not in a bid document, any previous transgressions of such a code of integrity with any entity in any country during the last three years or of being debarred by any other Procuring Entity. Failure to do so would amount to violation of this code of integrity.

c) In case of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/ dealer. There can be only one bid from the following:

i)	The Principal manufacturer directly or through one Indian agent on his behalf; and
ii)	Indian/foreign agent on behalf of only one principal.

d) Along with all the necessary documents/certificates required as per the tender conditions, the bidder should furnish a brief write-up, backed with adequate data, explaining their available capacity (both technical and financial), for manufacture and supply of the required goods/equipment, within the specified time of completion, after meeting all their current commitments.

e) Supporting documents submitted by the bidder must be certified as follows:

i)	All copy of supply/work order; respective completion certificate and contact details of clients; documents issued by the relevant Industries Department/National Small Industries Corporation (NSIC)/ manufacturing license; annual report, etc., in support of experience, past performance and capacity/capability should be authenticated by the by the person authorised to sign the tender on behalf of the bidder. Original Documents must be submitted for inspection, if so demanded.
ii)	All financial standing data should be certified by certified accountants, for example, Chartered Accountants/Cost Accountants or equivalent in relevant countries; and Indian bidder or Indian counterparts of foreign bidders should furnish their Permanent Account Number.

f) A bidder or any of its affiliates who participated as a consultant in the preparation of the design or technical specifications of the contract i.e. the subject of the bid; cannot participate in the bidding process.

g) Indian agents quoting on behalf of its foreign principal need to submit a copy of the agency agreement with the foreign principal detailing the services to be rendered by them on behalf of the principals, failing which the bid shall not be considered.

(h) Foreign bidders to disclose the name and address of agent and representatives in India and Indian bidder to disclose their foreign principal or associates.
