"https://etenders.gov.in/eprocure/app" in two cover system, for the Civil work "Proposed CFTRI School CSIR Boys toilet for at -CFTRI, Mysore " from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government organizations or those who have successfully carried out works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited.
