- 1. Online Item rate tenders are hereby invited through the e-tendering portal "https://etenders.gov.in/eprocure/app" in two cover system, for the Electrical work " Provision of New UPS and supply distribution to Director's Office, UNU Conference Hall and Director's Conference Hall at CSIR-CFTRI, Mysore." from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government organizations or those who have successfully carried out works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in this NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates, valid Electrical contractor and supervisory license.
- 2. The Estimated cost of work is Rs. 02,50,991.00 (Rupees Two Lakhs Fifty Thousand Nine Hundred and Ninety One only) based on CPWD DSR-2018 (Including relevant current cost index) and prevailing market rates inclusive of GST. Duration of contract for carrying out of the work will be 60 days (Sixty Days) from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
- 3. Bid Submission: Bids shall be submitted through online at CPP Portal: https://etenders.gov.in/eprocure/app by the tenderer, as per date given in Critical Date Sheet below.
