Earnest Money Deposit (EMD) of ₹2,78,000/- (Rupees Two lakh seventy eight thousand only) will be required to be paid in the form of Demand Draft/Bankers cheque from Scheduled Bank/Nationalised Banks in favour of "The Director, CSIR-CFTRI" payable at "Mysuru" and the scanned copy of the same should be uploaded during the submission of Tender duly signed digitally. EMD must be valid for minimum 90 days from the date of publication of the NIT.

Since the bid is to be submitted online, the Original EMD should be sent by post to reach this office before bid submission end time or put in the tender box kept in Establishment VII of CSIR-CFTRI, Mysuru. Tenders submitted without EMD and incomplete tenders shall be summarily rejected. CSIR-CFTRI will not be responsible for any postal delay.

MSME/NSIC Registered firms shall be granted exemption for EMD only. The MSME/NSIC units claiming exemption of EMD should enclose valid MSME/NSIC Registration certificate for Estate Maintenance Services, failing which bid will be rejected.
