- 1. Online Item rate e-tender is invited through the e-tendering https://etenders.gov.in/eprocure/app in two cover system from the eligible contractors for the work "Renovation (Civil and Electrical) of old Dehydration unit & Stores building to establish Common Incubation Centre under PMFME Scheme at CSIR - CFTRI, Mysuru". The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates and duly certified annual turnover certificate. The contractor will be required to produce proof of possessing valid Electrical license or to get the electrical work completed through licensed Electrical contractor only if any.
- 2. The Estimated cost of work is Rs 31,06,971/- (Rupees Thirty One Lakhs Six Thousand Nine Hundred Seventy One Only) based on CPWD, DSR-2018 (Including relevant current cost index) and prevailing market rates inclusive of GST. The Earnest Money Deposit (EMD) is exempted as per CSIR OM No11-15(193)/2021-Engg dt 17.02.2021. Proforma in respect of EMD shall be uploaded in prescribed format by the firms/contractor letter head with seal and signature. Duration of contract for carrying out of the work will be 120 days (One Twenty Days) including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
- 3. **Bid** Submission: Bids shall submitted through online CPP Portal: be at https://etenders.gov.in/eprocure/app by the tenderer, as per date given in Critical Date Sheet below. The instructions for the submission of e-tender are available on the CPP portal i.e. https://etenders.gov.in/eprocure/app under the "Instruction for Online Bid Submission". All the intending tenderers are requested to go through these instructions before entering into the process of e-tendering of this work and advised to visit again CPP Portal regularly till closing date of submission of tender for any corrigendum/ addendum/ amendment. Manual tenders shall not be accepted.
